DESCRIPTION

BacTrace Anti-*E. coli* O157 Latex Beads are navy blue latex beads coated with KPL's BacTrace Anti-*E. coli* O157, Molecular Grade antibody (Cat. No. 01-95-90-MG). This antibody is specific for *E. coli* O157. Latex conjugates can be utilized as a tool in agglutination assays. Agglutination assays are rapid tests often used in tandem with other bacteria identification assays to confirm the presence of specific bacteria in a sample.

FORM/STORAGE

Suspension. One vial provides enough material to perform 50 agglutinations. Store at 2-8 °C. DO NOT FREEZE! Stable for a minimum of 1 year from date of receipt when stored at 2-8 °C.

STABILIZER AND PRESERVATIVE

Bovine Serum Albumin (BSA) is added as a stabilizer. 0.02% sodium azide is added as a preservative. Non-sterile.

MATERIALS REQUIRED BUT NOT PROVIDED

Sterile PBS Positive control Agglutination plates or slides

SUGGESTED PROTOCOL

(Results may vary based on how the bacteria are procured and treated).

PLEASE NOTE: Working with pathogenic

bacteria requires that certain safety measures be followed. Please follow all required aseptic techniques, as well as good laboratory practice. Endeavor to avoid aerosol formation, and perform necessary work in a biosafety cabinet. All contaminated materials should be autoclaved or disinfected prior to disposal. VORTEX BEADS THOROUGHLY PRIOR TO USE!

- 1. Select one colony from an agar plate, and resuspend in $100 \ \mu L$ of sterile PBS.
- 2. Prepare 20 μ L serial dilutions in sterile PBS from the initial 100 μ L sample.
- 3. Add each dilution to the sample card or slide.
- 4. After vortexing, add 20 μ L of latex beads to each sample.
- 5. Rock gently for up to five minutes.
- 6. Observe for agglutination.

PLEASE NOTE:

- 1. At large concentrations of bacteria, a falsenegative (prozone) effect may be observed.
- 2. If beads appear aggregated in the negative control, sonicate before further use.
